

Icypeed Logistics Independence Promotion – Terms and Conditions

1. Introduction

These Terms and Conditions ("Terms") govern participation in the Icypeed Logistics Independence Promotion ("Promotion") organized by Icypeed Logistics Limited ("Icypeed," "we," "our," or "us"). By participating in this Promotion, customers agree to be bound by these Terms.

2. Promotion Overview

On 24th October 2025, in celebration of Zambia's Independence Day, Icypeed Logistics will offer customers a 24% consolidated discount on all qualifying parcels purchased online from Takealot.com, subject to the terms stated below.

3. Eligibility Criteria

To qualify for the Independence Promotion discount, customers must:

- a. Purchase goods from Takealot.com amounting to a combined parcel weight of 61 kilograms (61KG) or more.
- b. Submit proof of purchase in the form of a clear screenshot of their Takealot receipt(s) to Icypeed Logistics via the company's official communication channels (email, WhatsApp, or social media inbox).
- c. Ensure all submissions are made on 24th October 2025, within the promotional period stated below.

4. Discount Details

- a. The 24% discount applies only to the total shipping cost of consolidated parcels that meet the 61KG threshold.
- b. The discount cannot be combined with any other ongoing Icypeed promotions, loyalty programs, or discounts.
- c. Discounts will be calculated and applied after verification of qualifying receipts.

5. Promotion Duration

This offer is valid for one day only — from 00:00 hours to 23:59 hours on 24th October 2025 (Zambian time). Submissions or purchases made outside this period will not qualify for the discount.

a. Icypeed Logistics reserves the right to verify the authenticity of submitted Takealot receipts.



- b. Any falsified, altered, or unclear receipts will result in automatic disqualification from the Promotion.
- c. Successful applicants will receive confirmation of their discount via their preferred communication channel.
